

Privacy Policy:

This privacy policy discloses the privacy practices for www.greenoaks.org. This privacy policy applies solely to information collected by this web site. It will notify you of the following:

1. What personally identifiable information is collected from you through the web site, how it is used and with whom it may be shared.
