Call to Order: The Meeting was called to Order at 7:30 p.m.

Present: President Bernard Wysocki, Village Administrator Denise Kafkis, Caitlin Wagener. Committee Members present by way of Virtual attendance: Trustees Pete Furlong, Rich Glogovsky, Pam Milroy, Bryan Muskat, Dan Sugrue, John Wagener. Other Officials present: Village Attorney Rudy Magna, TIF Project Manager Ken Marabella, Village Engineer Ben Metzler, Al Maiden and Kevin Griffin by way of Virtual attendance. Mr. Bern Teitz, Mr. Doug Reitz and Mr. Dave Eubanks were also in attendance.

Non Agenda Items and Visitors:

The Village President and Board of Trustees Allocate Fifteen (15) Minutes at this time for those individuals who would like the opportunity to address the Village.

Mr. Reitz gave a presentation regarding a proposal for the Saddle Hill Subdivision, open space restoration project. He discussed clearing buckthorn, volunteer hours, open space clearing, and native planting. He is proposing to create a Savanah prairie with native plants and oak trees, and asking the Board for any financial assistance. Maintenance and total cost were discussed. Mr. Teitz discussed the improvement of O'Plaine Road and any funding assistance from the Board. Mr. Dave Eubanks discussed the shoreline, degraded habitat, grant money to assist in the project. A Recommendation to the Board for assistance will be done.
