MOTION by Wagener seconded by Milroy to recess the TIF Committee Meeting for a Special Village Board Meeting. Upon a voice vote the motion was approved. Chairperson Muskat recessed the TIF Committee Meeting at 7:30pm.

Chairperson Muskat reconvened the TIF Committee Meeting at 7:50pm

Special TIF Committee Meeting – Baker Road- Chairperson Muskat then led the Committee and consultants through the Agenda and PowerPoint presentation for the Special TIF Committee Meeting on Thursday, August 16 regarding Baker Road. All of the owners, taxpayers, and businesses along Baker Road have been invited to discuss the potential improvement of Baker Road and utilities. In order to expend TIF Funds, all owners must dedicate property for road right-of-way to create a Public Roadway. Trustees Muskat and Wagener, along with consultants Magna, Rickert and Marabella will each make part of the presentation to the owners. Several issues related to parking, landscaping, non-conformance, cost and project schedule were included in the presentation and anticipated to being discussed at the meeting. The Draft Option Agreement which 100% of the owners must sign was explained by Attorney Magna. The Option Agreements must be signed and returned to the Village within ninety days in order to be considered. It is anticipated that individual onsite meetings will be held with each property owner to explain the impact the right-of-way grant, and the construction will have on each property.
