The Year 2020 was a tough year to have "hope" for better days, but this is a new year, and 2021 is going to be much better, right?

Just envisioning better days ahead, can make you feel a little better. Even hoping for better weather is a good start for better days ahead.

Though we have all had to endure a lot of upheaval in our daily lives, I want to especially thank our Village Administrator Denise Kafkis, and her staff for continuing to "man" the Village office during all of 2020. Another thank you

goes to our Village Board, Clerk and consultants who have helped complete a great number of projects during the year. I just wanted to highlight a few.

In the second year of our road improvement project we spent \$2 million on rehabbing roads, adding sidewalks and repairing roads. We have now completed over 60% of our roads.

We completed a number of drainage and wetland mitigation projects. The restoration of ditches and streams and ponds will continue in the future.

We continue our work on invasive species removal, especially the buckthorn species. We completed most of the work in Reigate and Saddle Hill I Subdivisions. We also cleared the Lake Kathryn Park and the south side of Route 176.

We completed a water leak detection review of pipes and made repairs to the water pipes. We are currently providing new meters to accurately provide actual customer water usage.

Finally, I again wanted to thank all of our residents and businesses for their patience during our ongoing construction season.

"Hopefully" we will have a great year & return to a sense of normalcy.

Streets and Roads

Phase three of our Road Improvement Project resumes this Spring on a very ambitious schedule. Contractor bidding will take place over the next two months and RHMG will be doing the engineering for the project.

We will be focusing our attention in two specific areas of the Village that are sorely in need of maintenance. One is Thornbury Estates, which includes Minard Lane, Park Hill Lane, Crescent Knoll and Margate Drive. The other, to the north and west, includes Shannondale Drive, Heathercliff Drive, Woodview Drive, Harwood Drive and Irondale Drive. In addition to those, there will be road work on Red Fox Lane and Baker Road. As always, we will be replacing driveway aprons to provide a smooth transition to the road. Like last year, we're hopeful that this can all be completed by mid-September.

Please feel free to contact me should you have any questions about road repairs. In the meantime, if you notice potholes that need to be filled, please call our Village administrative office so that we can arrange for that to be done.

And as this is still winter, unfortunately, there's still plenty of snow to be anticipated. As always, if you feel that your property has difficult or blind areas that a snowplow driver may not be aware of, please consider placing temporary stakes in the areas of concern to help alleviate any possible damage that may occur.

Friendly Reminders

- Snow will be plowed when accumulation is **greater than 1"** on all streets
- Major intersections will always be salted during a plow event
- In the event of icy conditions, neighborhoods & side streets will be salted
- Any mailbox damaged by the contractor will be repaired or replaced with a temporary mailbox. Any related damages will be reimbursed up to **\$50** maximum.
- All claims must be made within **5 days of damage**
- The contractor will be inspecting all mailboxes to determine current conditions
- Consider marking areas of property and covering plants that are a concern for possible snowplow damage
- Please keep your garbage & recycle containers off the street during a plow event

How & Where Do You Blow Your Snow?



The Village begins plowing streets when snow is more than one inch deep and when freezing temperatures indicate there will be no melting. Many state and county roads such as Rt. 176, St. Mary's, Buckley and Guerin Roads are cleared by state or county crews (Guerin is a multi-jurisdictional road maintained by Village of Green Oaks, Libertyville Township and Village of Waukegan). Streets with high traffic volume, emergency routes, and bus routes on school days receive priority for plowing over residential, non-primary routes that typically do not have heavy traffic volume. There are several ways you can help keep the Village safe during the winter:

- **Clear your sidewalk.** This is especially helpful for children trying to get to school or for packages/mail delivered safely.
- **Consider helping senior citizens** who live nearby by shoveling their sidewalks.
- When you clear your driveway, **shovel or blow the snow onto the parkway to the right side of your driveway** as you face the street. **Do not** deposit on your neighbor's property.
- **Park vehicles off the street.**
- Make sure your **mailbox is 12 inches from the curb** and that the post is secure.
- **Adopt a fire hydrant and keep it clear of snow.** It's there to protect you.
- **Please stay clear of street while shoveling or snow blowing** your driveway if you see a plow or any traffic. The safety and well-being of our community is our number one priority!
- During snow storms and extreme conditions the Village monitors the weather and will provide updates when available.

Public Works

The New Water Meters Are Here – As we advised in the last edition, the Village Engineer determined that a component of the unmetered water loss finding was that many of the water meters in the Village are aging out and improperly under-reporting the residential water usage. After consulting with the Village Engineer, the Public Works Committee decided to replace all of the water meters in the Village north of the METRA tracks. The water meter replacement is now underway. Some of you have already had your new meters installed. If not, you will be receiving a letter in the coming days or weeks asking you to call and schedule your installation. Please do so promptly upon receipt of your scheduling letter. The Village is performing the installation in phases by location, so don't delay when given the opportunity to schedule. As of February 9th, 417 meters have been replaced which is approximately 90%.

SWALCO News – Due to ongoing safety concerns associated with COVID-19, the Solid Waste Agency of Lake County (SWALCO) has modified its household chemical waste (HCW) collection program. All HCW collection events are currently being held on Saturdays at the Gurnee facility. This modification will continue into the summer months of 2021 when the agency will re-evaluate its collection program to possibly include a one-day mobile collection event in the fall. In the meantime, to help address the increasing demand for more events; an additional collection event will be added to the Winter, Spring and early Summer months of 2021, dates to be determined. This will add a third event for those selected months, increasing the number of collection events from two events per month to three events per month (depending on demand). For the foreseeable future, all collection events are scheduled for Saturdays only. Contractual restrictions prevent SWALCO from posting HCW collection events on the appointment calendar greater than one month prior to the event date. If you are unable to find an open appointment, please keep trying, new appointments do become available especially a few days before a scheduled event. Under the permits with the IEPA and local government, SWALCO is only allowed to collect and service what its warehouse can safely hold – and it typically services nearly 170 households/vehicles for every event. And since the reopening, folks have been quick to get a time slot.

Spring Rains are Just Around the Corner – Even though it's cold outside, Spring is just around the corner and so are the proverbial "April Showers." In late September, the Village completed a series of upgrades to the ditching work that was completed along Kenton earlier this summer. The Kenton work is designed to continue our work at reducing the severity and frequency of nuisance flooding in and around Doe Lake. The additional work was performed in the swale between Kenton and Oak Grove School. This work included regrading and upgrades to the berm along the swale. Walkers should notice that the school path should not be underwater as often.

2020 has flown by and has been a year like no other, and if you're anything like me, you tend to quickly move on to all that the New Year will bring. However, I'd like for us to pause for a few moments to remember those close family members and friends who were a painful loss, may it be a reminder to take care of one another to the best of our abilities.

Now, let's take a moment and celebrate all the good things that have taken place in our community because each and every one of us have been part of this history. The Green Oaks Community came together and has shown their resilience to meet unprecedented challenges. Since March 31st all Board Meetings have met virtually, not stopping for even one second, while moving ahead to finish the year with more than \$3 Million in completed projects.

Beginning with the 2nd year in our Road Improvement Project, to date have completed more than 60% of local roadway, additional land acquisitions, ecological restorations, drainage & wetland mitigation projects, and the village-wide water meter replacement project. In our TIF District the soon to be complete Rt. 176 & Bradley Rd intersection signals, Rt. 176 widening project phase 1, Rt. 176 Streetscape-invasive species removal restoration program. In addition, the Baker Road ROW Easement Agreements were finally approved, and we finished televising the sanitary sewer and have completed the 1st half of the Sanitary Sewer Repairs/Replacement Project.

With 2020 being a year filled with uncertainty, we must humbly say “THANK YOU” to all of our residents and business owners for re-investing in Green Oaks. Because of all the home and commercial improvements and developments our Building/

Community Development group has continued to thrive as we've seen a 79% increase in building permits in 2020. It has been truly heartwarming to see all the humanitarian efforts exhibited by our residents with their outpouring of good will by donating generously hundreds of coats through the GLMV Coat Drive for our local Veterans.

Last but certainly not least, the Village of Green Oaks' first ever Santa Parade! I've often heard the words “It takes a Village” well, that's exactly what it took, but what a momentous event had by all. It all began with Ms. Abbott, a resident of Green Oaks, inquiring if our Village had any plans hosting such an event. Thanks to Chief Carani, of the Libertyville Fire Department (Special Guest) and Ben Metzler, Village Engineer for developing our Santa Route and the LFD crew for building such an amazing float that supported Santa Claus. The Lake County Sheriff together with Ben Metzler led the Santa Parade in stellar fashion, followed by our Village Landscaping Contractor ~ Northshore Turf who gently towed Santa (Special Guest), our Village Snow Plow Contractor ~ Midwest Snow Solutions, who had their trucks so awesomely decorated, Mayor Wysocki following directly behind Santa, and our amazing Village Board Members and Staff. A big thank you to Marabella & Associates for their generous contribution for the magnetic “Village of Green Oaks” signs that we affixed to our cars, thank you Ken!

As we move forward into 2021, one thing has never been clearer, we will continue our mission of delivering exemplary municipal services that is responsive to our entire community and consistent with our history, culture and unique character.

The Committee is dedicated to providing the best land development within the Village as well as the health, safety, and general welfare of our residents and businesses.

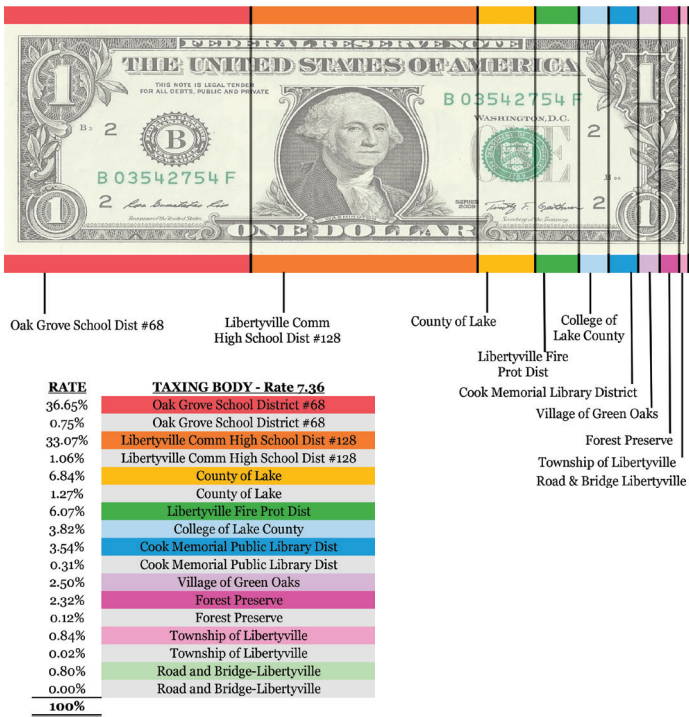
The Building Department is responsible for plan review, permits, and inspections for multifaceted construction projects ranging from commercial buildings to residential roofs as well as compliance to Building and Zoning Codes. The Village Building Commissioner is Rich Politowicz and he has office hours at the Village Hall Monday and Wednesday from 11am to 12pm. The Village Engineer is Ben Metzler and he has office hours at the Village Hall Wednesday from 11am to 12pm. All permit applications may be obtained at the Village Hall Monday through Friday from 9am to 2pm or by simply downloading the application from the Village’s website at greenoaks.org. Please note there is no charge for Ash Tree Removal permits.

The Green Oaks Village Hall is an important and historical icon in the county. The Building Committee continues to renovate the Village Hall to ensure building and property standards are kept current. Upcoming improvements will include replacing/refurbishing the two entry areas and doors and completing the refurbishment of the sub-basement washrooms. The Building Committee continues to operate efficiently while being fiscally responsible by remaining within the budget.

Green Oaks - 60048

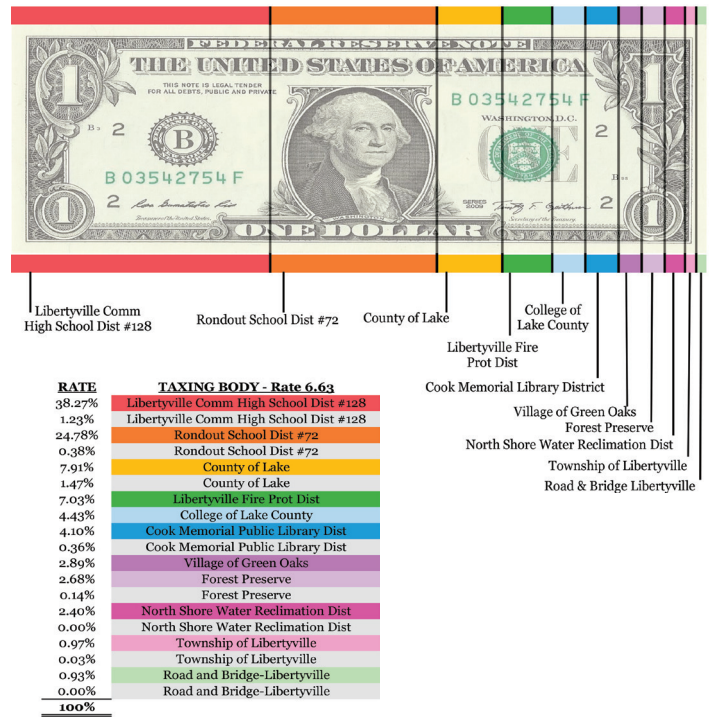

In 2018, the Village Residents voted to pass a referendum which allowed the Village to adopt an ordinance (2018-O-07) establishing a Local Road Rehabilitation Fund which requires all General Corporate Property Tax Revenue to be deposited into said fund for the uses and purposes solely related to the Road Improvement Project. At the end of Year 2 of this project, the Village has rehabilitated 60% of local roadway.

Annexation, Planning & Zoning

Despite the challenges that COVID presents with trying to meet, the Village was very busy this year with Annexation, Planning and Zoning. Presently, the Village is in the final process of updating our Village Comprehensive Plan. The Comprehensive Plan serves as a roadmap of how the Village will grow and develop over the next 15 years or so. There will be a "virtual" Public Hearing of the Plan Commission on February 10th, 2021 at 7:30pm to review the final draft of the Comprehensive Plan. Please check the Village website if you would like to participate.

The TIF District has performed some infrastructure improvements. Water and sewer repairs were made and the Rt. 176 & Bradley Road intersection was improved. Other improvements are in the planning stage and will be implemented in the near future. The Phase 1 Engineering continues to prepare for a "Shovel ready" project to widen Rt. 176 if State funds become available. In addition, with TIF funds, the Village finished the first phase of a streetscape project of removing buckthorn along the Rt. 176 corridor near Arcadia Road. The work is budgeted to continue for the 2021/2022 season. This also facilitates the potential road widening project.



Putting the "Green" Back Into Green Oaks – Part II

Over the years the Village has supported efforts to remove buckthorn and other invasive species throughout the Open Space areas of the Village. Lake Kathryn, Reigate Woods and Saddle Hill have benefited from the Village support on this endeavor. This winter Arbor Lakes will begin clearing the buckthorn from their open space area. Glenmore Woods has been partnering with the Lake County Forest Preserves to remove buckthorn from their community. If you are interested in learning about why buckthorn should be removed, replacement screening, or just some advice on how to get started, please reach out to me and I can help get you started.

In the Fall publication of the Oak Leaf, we outlined some restoration efforts throughout the Village that were being undertaken. A quick update:

Lake Kathryn – Last fall we reported that there would be restoration efforts undertaken at the Village open space. Since then, the front area has been completely cleared and then seeded with a native seed mix, the swale area has been mowed and treated with an herbicide and the lake shore has started to be cleared.

With winter upon us, we will start some stewardship days (volunteer opportunities) to continue to clear the shoreline and surrounding areas of buckthorn. Watch for future blackboard email notices where we will be announcing some workdays. All are welcome to participate. In addition, this is a great way for high school students to get community service hours.



The newly acquired Corner lot at Rt. 137 and O'Plaine – Restorations will begin shortly to remove the invasive buckthorn and other invasive species from the property. The contractor will be cutting and stacking the buckthorn and then burning the brush piles. It is a very cost-effective restoration method. This spring the property will be seeded with a native seed mix.

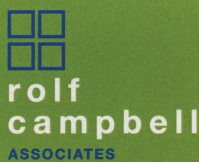

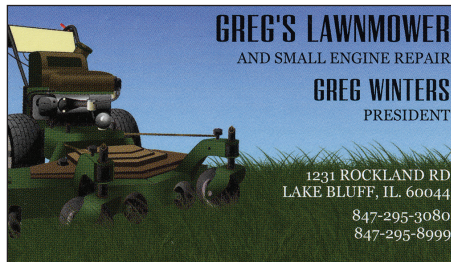

Fire Safety Message

When the snow melts and the flowers start to bloom something inside of us triggers a reaction to clean. Maybe that's how the term "spring cleaning" came about. The truth of the matter is many of us perform large clean up projects in our homes each spring, out with the old in with the new. One thing almost everyone is sure to encounter during a large cleanup is household hazardous waste (HHW). These items can include; old paint, pesticides, gasoline, waste oil, cleaning products and other chemicals often used for household projects.



To avoid the potential risks associated with HHW, it is important that people always monitor the use, storage, and disposal of products with potentially hazardous substances in their homes. Improper disposal of HHW can include pouring them down the drain, on the ground, into storm sewers, or in some cases putting them out with the regular trash.

The dangers of such disposal methods might not be immediately obvious, but improper disposal of these wastes can pollute the environment and pose a threat to the health of humans and animals. Certain types of HHW have the potential to cause physical injury to our waste water treatment workers, contaminate our wastewater treatment systems if poured down drains or toilets and they can present hazards to children and pets if left around the house.

Some quick tips for the safe handling of household hazardous wastes include:


- Follow any instructions for use and storage provided on product labels carefully to prevent any accidents at home.
- Be sure to read product labels for disposal directions to reduce the risk of products exploding, igniting, leaking, mixing with other chemicals, or posing other hazards on the way to a disposal facility.
- Never store hazardous products in food containers; keep them in their original containers and never remove labels. Corroding containers, however, require special handling. Call the fire department for instructions.
- When leftovers remain, never mix HHW with other products Incompatible products might react, ignite, or explode, and contaminated HHW might become unrecyclable.
- Check with your local environmental, health or solid waste agency for more information on HHW management options in your area.
- Remember, even empty containers of HHW can pose hazards because of the residual chemicals that might remain so handle them with care also.

Bonfire Burn Reminder

Fires are a pleasant part of all seasons, but can be less pleasant for someone who has allergies or respiratory issues. Please be considerate of your neighbors if they have those conditions. Also, there are rules in the Village to make sure everyone is safe and healthy during an outdoor recreational fire. They are found in the Village code in Chapter 8 and shown on the permit itself. (These are different from the rules in unincorporated Lake County.) The application outlines what you can and cannot do. A permit is required for all fires, but the permits are free and can be obtained at the Village Office. So, get a permit before you burn. Again, please be considerate and check with your neighbors that your fire will not have an adverse effect on them.

4-8-4 REGULATIONS:			
a. Burning hours for fires by permit shall be 9:00 a.m. - 7:00 p.m. b. No outdoor recreational wood burning fire shall be larger than 24 inches in diameter and no more than 36 inches in height. No fire for which a permit has been issued shall be larger than 5 feet in diameter and no more than 5 feet in height. c. All recreational fires shall be contained within a portable fire pit (defined as a device sold commercially, and designed and intended to contain and control outdoor wood fires), a fire pit surrounded by stones not less than 1 foot high, or solid masonry fireplace designed and built for such purposes. Such units shall only be used in accordance with manufacturer's recommendations. d. Burning shall be constantly attended by the resident of the property or the person starting the fire. e. No burning shall occur or be maintained when the wind velocity is in excess of ten miles per hour. f. No burning shall occur on any public street or sidewalk. g. Recreational fires shall not be used for the purpose of disposal of garbage, debris construction waste or landscape waste. Only wood, charcoal or commercially sold burning logs shall be used in recreational fires. All recreational fires shall be extinguished by 11:00 midnight. h. Fires shall be extinguished in such a manner as not to produce smoke.			
4-8-3 PENALTY: Any person who violates any provision of this Chapter shall be fined not less than one hundred dollars (\$100.00) for the first such offense and not less than two hundred dollars (\$200.00) nor more than seven hundred fifty dollars (\$750.00) for each subsequent offense. I hereby certify that the above information is correct and understand that if open burning is permitted, it will be subject to the various above stated restrictions, conditions and provisions of the issued permit and that open burning cannot begin until a permit has been issued. 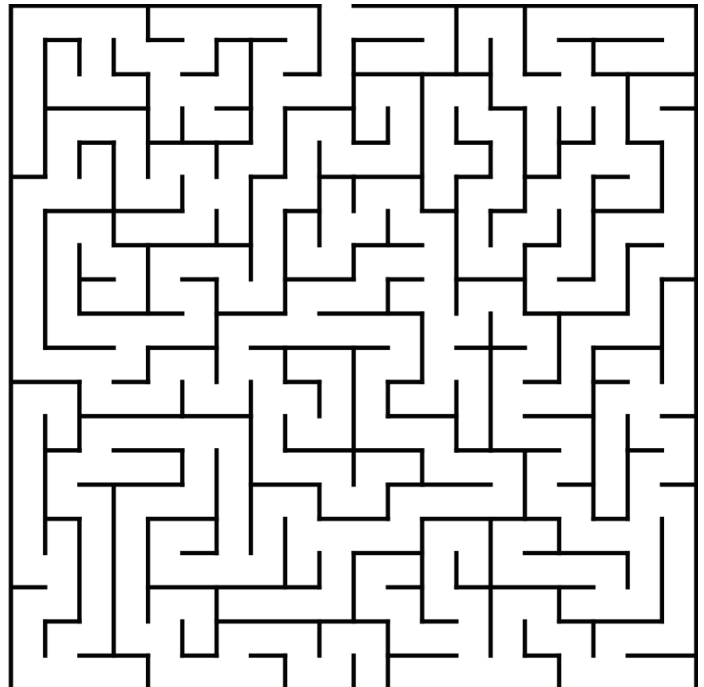
