If there are any changes needed on the business license application, please make changes directly on the application. You can also find a blank copy of the business license application online if you choose to make the changes that way. Please be sure to sign the back (page 2) of the application and indicate if you would like to be featured on our website free of charge.

The Village will accept payment in the form of a check, cash or credit/debit card. If paid with a credit/debit card, a 2% transaction fee is applied. You can also pay online (greenoaks.org) or over the phone. Please contact the Village Administrative Office at (847) 362-5363 if you choose to pay over the phone.

The Village of Green Oaks requires all businesses located within the municipal boundaries to obtain a Village Business License (Village Code: Title 13 – Chapter 2). The annual fee for a Business License is sixty-five (\$65) dollars if purchased by January 31st. If purchased between February 1st and June 30th the fee will be one hundred and thirty (\$130) dollars. If purchased on or after July 1st the license fee will be one hundred and fifty (\$150) dollars. Failure to comply with this ordinance may result in a fine up to seven hundred and fifty (\$750) dollars for each day that a violation exists.

In a continuous effort to streamline the services provided by the businesses within the Village, the Village has developed an online Business Directory describing available services. A business can also pay to advertisement in the Village's quarterly newsletter. The application is included, and the fee is one hundred and fifty (\$150) dollars if you wish to participate.

The Village of Green Oaks is a member of the GLMV Chamber of Commerce. The GLMV Chamber of Commerce is the advocate for businesses in the communities of Green Oaks, Libertyville, Mundelein, Vernon Hills and the surrounding area.

Business License Agreement Application

Applicant agrees to the following:

The undersigned hereby certifies under penalty of perjury that he/she is the duly authorized agent of the applicant, that the information contained in this application is true and that the applicant agrees to operate the business in accordance with all applicable Federal, State and Local statutes, laws and regulations. The applicant understands that incomplete, false or incorrect statements could result in the denial or revocation of the license applied for. This application will be considered complete only when all sections are completed in their entirety.

Ordinance 13-2-17: License Fees; Required Licenses:

- A. It shall be unlawful for a business to operate within the village without a business license.
- B. License fees under the terms of this chapter, for the businesses, occupations, activities and uses set forth, shall be sixty five dollars (\$65.00) if purchased by January 31 of the license year. The license fee shall be one hundred thirty dollars (\$130.00) if purchased between February 1 and June 30 of the license year. If purchased on or after July 1 of the licensed year, the license fee shall be one hundred fifty dollars (\$150.00). The license year shall be January 1 to December 31. The full license fee shall be paid annually, and no fee shall be prorated for a term of less than one year. Proof of any bond or liability insurance policy required by this chapter shall be provided with the license fee. (Ord. 2021-O-22, 12-15-2021)

This application does not authorize the operation of a business for which an application is applied for. The business shall not be operated until a Business License is issued. This application must be completed in its entirety and returned along with the annual Business License fee made payable to The Village of Green Oaks ~ 2020 O'Plaine Road ~ Green Oaks ~ IL ~ 60048

Applicant understands that any business cannot operate without receipt of a Village of Green Oaks business license and said license must be displayed for examination by the Village Officers during reasonable business hours.
